Subject:	Updates to Processing Air Ambulance - Rotary Wing Claims
Date:	September 7, 2022

Effective October 1, 2022, responsibility for reviewing and authorizing air ambulance claims submitted to Maryland Medicaid will be moved to the Maryland Department of Health's Utilization Control Agent (UCA), Telligen. Telligen will be offering real-time online training to providers on how to submit claims for processing. For providers who cannot attend one of the available online training dates, Telligen will publish a recording of the training accessible at your convenience on the <u>Qualitrac training site</u>.

Please see below for Telligen training dates. The second session is a repeat of the first.

Maryland Medicaid providers submitting claims for payment after October 1, 2022 will be required to use the Qualitrac Provider Portal to submit requests for review. Provider organizations new to Qualitrac will need to register to gain access by following the registration link at <u>https://telligenmd.qualitrac.com/</u>.

All provider organizations must complete the online DocuSign registration process for Qualitrac access prior to October 1, 2022. Once completed, the provider organization's authorized representative will receive a copy of the fully executed Provider Portal Agreement for their records.

The Department recommends that provider organizations register for the Qualitrac Provider Portal at least one week prior to October 1, 2022 as it can take up to a week to process. Provider organizations that already have access to Qualitrac should work with their Authorized Official responsible for managing accounts within their organization.
